

## DIGITAL PLATFORM USERS TERMS

These terms ("Terms") constitute a legal agreement entered into between you and Highland Capital Brokerage, Inc. ("HCB") governing your use of the EasyLife or Quotacy For Advisors platform (the "Platform"). By acknowledging these terms, you agree as follows:

1. **Service and System Control.** HCB has and will retain sole control over the operation, provision, maintenance and management of the Platform. HCB reserves the right, in its sole discretion, to make any changes to the Platform that it deems necessary or useful. HCB may, in its sole discretion and at any time, modify, cancel or suspend the Platform, or any part thereof, without cause and without notice.
2. **Responsibility for Use.** You have and will retain (i) sole responsibility for all access to and use of the Platform by your authorized users, and (ii) sole responsibility for the results obtained from any use of the leads or other materials generated through the Platform. If you are registered with any broker dealer or registered investment advisor firm, you are responsible for compliance with all policies and procedures applicable to you as a result of such registration, including obtaining any permissions required in connection with your use of the Platform.
3. **Use Restrictions.** You acknowledge and agree that you do not acquire any ownership rights by using the Platform. You may not: (a) copy the Platform or any software or programming related thereto; (b) modify, translate, reverse engineer, decompile, or create derivative works based upon the Platform, or any software or programming related thereto, or (c) rent, lease, transfer, resell and/or otherwise transfer rights to use the Platform. dress and URLs ("Marks") rests with the other party, and both parties agree that neither will do anything inconsistent with such ownership. All uses of a party's Marks, and all goodwill associated therewith, will inure solely to the benefit of the owner.

- b. **Limited License.** Each of HCB and you hereby grants to the other party a non-exclusive, non-sub licensable, non-transferable right to use its Marks solely for the purposes contemplated in connection with "white labeling" the Platform. For the avoidance of doubt, all domain names created to host the Platform shall be owned by HCB. HCB shall not use any of your Marks (whether individually or in combination, or in whole or in part) in or in connection with the advertising, promotion, marketing, or distribution of any goods, services, or technologies other than the Platform.
